DISCUSSION ITEMS

Oaktree Academy, Inc. Lease Renewal Agreement - South Hamlin

It is my recommendation that the Board approve the renewal of the agreement with Oaktree Academy, Inc. to lease the South Hamlin building for use as a child care center. The renewal will continue with similar payment terms as previously authorized by the Board from the lessee. Base monthly lease payments will be \$3,000 and the term of the lease will be effective January 1, 2020 and terminate on December 31, 2024.

South Hamlin Building Roof Replacement

The roof on the South Hamlin Building is in need of replacement. The District's original sinking fund plan called for the replacement of the roof in 2019-2020. The District has worked with G. Freeland Roofing Systems, Inc. who has recommended the replacement of the roof. We will discuss prioritizing this repair and developing a plan to seek competitive bids for the roof replacement using sinking fund proceeds.

Approval of Oaktree Academy, Inc. Lease Renewal Agreement - South Hamlin

It is my recommendation that the Board approve the renewal of the agreement with Oaktree Academy, Inc. to lease the South Hamlin building for use as a child care center. We will need a motion to authorize the Superintendent to execute a lease agreement between the District and Oaktree Academy, Inc., as described above.

Closed Session: Emergency Operations Security Planning - MCL 15.268 Section 8(k)

We will need an action item to enter into closed session, pursuant to the Open Meetings Act, MCL 15.268, Section 8(k). The school board will consider emergency operations security planning to prevent potential threats to the safety of the students and staff.

Section 1308b of the Revised School Code requires that school districts implement an emergency operations plan beginning in the 2019-20 school year. By January 1, 2020, school officials must develop an emergency operations plan for each school building that the school operates. School officials must develop the plan and it must be adopted by a majority vote of the school's board. The Legislature added

Section 8(k) to the OMA (effective March 27, 2019) to allow a board to deliberate in closed session to "consider security planning to address existing threats or prevent potential threats to the safety of the students and staff."

Section 1308b requires that the emergency operations plan include guidelines and procedures that address: School violence and attacks; threats of school violence and attacks; bomb threats; fire; weather-related emergencies; intruders; parent and pupil reunification; threats to a school-sponsored activity or event whether or not it is held on school premises; a plan to train teachers on mental health and pupil and teacher safety; a plan to improve school building security; an active violence protocol; continuity of operations after an incident; and a vulnerability assessment.

Section 1308b also requires school officials to notify the Michigan Department of Education (MDE) of the completion of its emergency operations plan review and the adoption of its emergency operations plan within 30 days of completion or adoption of such plan. MDE will report this information to the MSP Office of School Safety. Emergency operations plans developed under Section 1308b and any information provided to MDE or the MSP under Section 1308b is exempt from disclosure under FOIA.

The District met with Liz Reimink, Emergency Manager (EM) for the County of Mason, on Friday, November 22, 2019. The EM reviewed the plans that she had on file in her office with the District and provided approval of the plans to be submitted to our Board for approval in compliance with the statute referenced above.

Further, MCL 15.267 Sec. 7(1) states, "A ³/₄ roll call vote of members elected or appointed and serving is required to call a closed session, except for the closed sessions permitted under section 8(a), (b), (c), (g), (i), and (j). The roll call vote and the purpose or purposes for calling the closed session shall be entered into the minutes of the meeting at which the vote is taken." Thus, a ³/₇ roll call vote of members elected or appointed and serving will be required to enter into closed session.

Approval of Emergency Operations Plan: Pursuant to MCL 380.1308b

The Board will enter back into open session and will need an action item to approve the District's Emergency Operations Plan (EOP), pursuant to Section 1308b of the Michigan Revised School Code. The District is required to provide notice to the department of the adoption of an emergency operations plan not later than 30 days after the adoption of the emergency operations plan.
