CITIZEN PARTICIPATION

Review Board Policy 0167.3: Public Participation at Board Meetings

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on District matters.

To permit fair and orderly public expression, the Board shall provide a period for public participation at every regular meeting of the Board and publish rules to govern such participation in Board meetings. The rules shall be administered and enforced by the presiding officer of the meeting.

The presiding officer shall be guided by the following rules:

- A. Public participation shall be permitted as indicated on the order of business, or at the discretion of the presiding officer.
- B. Participants must be recognized by the presiding officer and will be requested to preface their comments by an announcement of their name, address, and group affiliation, if and when appropriate.
- C. Each statement made by a participant shall be limited to three (3) minutes duration.
- D. No participant may speak more than once.
- E. Participants shall direct all comments to the Board and not to staff or other participants.
- F. The presiding officer may:
 - 1. interrupt, warn, or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, obscene, or irrelevant;
 - 2. request any individual to leave the meeting when that person does not observe reasonable decorum;
 - 3. request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
 - 4. call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action;
 - 5. waive these rules with the approval of the Board when necessary for the protection of privacy or the administration of the Board's business.
- G. The portion of the meeting during which the participation of the public is invited shall be limited to thirty (30) minutes, but the timeframe will be extended, if necessary, so that no one's right to address the Board will be denied.
- H. Tape or video recordings are permitted. The person operating the recorder should contact the Superintendent prior to the Board meeting to review possible placement of the equipment, and agrees to abide by the following conditions:
 - 1. No obstructions are created between the Board and the audience.
 - 2. No interviews are conducted in the meeting room while the Board is in session.
 - 3. No commentary, adjustment of equipment, or positioning of operators is made that would distract either the Board or members of the audience while the Board is in session.

Ludington Elementary School Open House Planning

We continue to work on planning for the open house which is scheduled for December 11th. I will give an update on Monday at the meeting.

Review Bids on Foster Elementary School Property

The window for accepting bids on the Foster Elementary School property closed at 4:00 pm on November 10th. One bid has been received. The bid will be reviewed to determine if the district is prepared to accept or reject it.

Review Bids on Pickleball Court Resurfacing

The district has solicited bids for resurfacing the eight (8) pickleball courts at Oriole Field. This need has been identified due to multiple areas of the courts where cracking has become significant. The cracking has been filled repeatedly within the last year, proving it is only a temporary fix, and more substantial resurfacing work has become necessary. This scope of work can be funded using the Sinking Fund instead of the General Fund. The bids received will be reviewed in further detail.

Sub Teacher Rates

Substitute teacher pay rates will be reviewed as, like many schools in the state, it is difficult to find enough subs to cover all of the daily staff vacancies. We are proposing increasing the daily rate to \$125.00 per day from \$85.00 per day.

Elementary Bond Project Application and Certificate for Payment #19

We will need to approve the certificate for payment on the elementary school bond project and to authorize the District to pay the certificate for payment in the amount of **\$1,476,005.79**, as certified by the architect and construction manager, and as outlined in the Certificate for Payment. The District received the pay application information from the construction manager to process on November 4, 2021.
