## **Update on Lakeview Elementary Principal Hiring Process**

The posting for the Lakeview Elementary principals position closed on November 21, 2018. There were 25 applications for the position, and candidates were selected for first round interviews from that pool, which took place on November 30, 2018. One of the interviewed candidates has been invited back for a second round interview that is scheduled for Thursday, December 6, 2018. The candidate selected for a second round interview did an amazing job in their interview. If a candidate is selected for hiring, a recommendation will be presented to the personnel committee on Friday after the second round interview has taken place, and the full Board on Monday; otherwise, options available to the District, including interim solutions will be discussed, so that a replacement is ready in January.

## Review of Second Reading - NEOLA Policy Update: Volume 33, Number 1
