CITIZEN PARTICIPATION

Review Board Policy 0167.3: Public Participation at Board Meetings

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on District matters.

To permit fair and orderly public expression, the Board shall provide a period for public participation at every regular meeting of the Board and publish rules to govern such participation in Board meetings. The rules shall be administered and enforced by the presiding officer of the meeting.

The presiding officer shall be guided by the following rules:

- A. Public participation shall be permitted as indicated on the order of business, or at the discretion of the presiding officer.
- B. Participants must be recognized by the presiding officer and will be requested to preface their comments by an announcement of their name, address, and group affiliation, if and when appropriate.
- C. Each statement made by a participant shall be limited to three (3) minutes duration.
- D. No participant may speak more than once.
- E. Participants shall direct all comments to the Board and not to staff or other participants.
- F. The presiding officer may:
 - 1. interrupt, warn, or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, obscene, or irrelevant;
 - 2. request any individual to leave the meeting when that person does not observe reasonable decorum:
 - 3. request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting:
 - 4. call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action;
 - 5. waive these rules with the approval of the Board when necessary for the protection of privacy or the administration of the Board's business.
- G. The portion of the meeting during which the participation of the public is invited shall be limited to thirty (30) minutes, but the timeframe will be extended, if necessary, so that no one's right to address the Board will be denied.
- H. Tape or video recordings are permitted. The person operating the recorder should contact the Superintendent prior to the Board meeting to review possible placement of the equipment, and agrees to abide by the following conditions:
 - 1. No obstructions are created between the Board and the audience.
 - 2. No interviews are conducted in the meeting room while the Board is in session.
 - 3. No commentary, adjustment of equipment, or positioning of operators is made that would distract either the Board or members of the audience while the Board is in session.
- I. Each Board agenda will include the following statement, "Public participation shall be permitted only as indicated on the order of business."

Annual Report on Bullying Incidents and Medication Distribution in the Schools

The District has completed the District submission of the School Infrastructure Database and the submission of the annual report on bullying that is required to be shared with the Board of Education. The annual results are shown in the table below:

Update on Title IX Complaint Outcome

We will discuss an update on the Title IX complaint outcome with the committee, as outlined below. In this case, the Complainant alleged that the District failed to provide a prompt and equitable response to a Title IX retaliation complaint made by the Parent. Specifically, the Complainant told OCR that the Parent complained to the District that the coach was mistreating the Student in retaliation for the Parent's February 2018 gender discrimination complaint, and the District failed to timely address that complaint. However, the facts do not support that the Student's parents ever raised a Title IX retaliation complaint to the District.

OCR concluded that there is insufficient evidence that the District violated Title IX as alleged. According to OCR, the complaint allegation that the District failed to promptly and equitably respond to an internal Title IX retaliation complaint made by the Student's parents is not supported by the facts, which show that the parents' complaint to the District did not include a Title IX retaliation allegation. OCR finds that the evidence is insufficient to support a finding of a violation of Title IX as alleged.

Evaluation of the Superintendent

We will discuss the evaluation of the superintendent and the process that the Board desires to use to either complete an evaluation of the superintendent. It is my recommendation that a modified evaluation of the superintendent be completed for the 2020-2021 school year, as student, teacher, and principal achievement data is not available due to COVID-19.
