CITIZEN PARTICIPATION Review Board Policy 0167.3: Public Participation at Board Meetings

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on District matters.

To permit fair and orderly public expression, the Board shall provide a period for public participation at every regular meeting of the Board and publish rules to govern such participation in Board meetings. The rules shall be administered and enforced by the presiding officer of the meeting.

The presiding officer shall be guided by the following rules:

- A. Public participation shall be permitted as indicated on the order of business, or at the discretion of the presiding officer.
- B. Participants must be recognized by the presiding officer and will be requested to preface their comments by an announcement of their name, address, and group affiliation, if and when appropriate.
- C. Each statement made by a participant shall be limited to three (3) minutes duration.
- D. No participant may speak more than once.
- E. Participants shall direct all comments to the Board and not to staff or other participants.
- F. The presiding officer may:
 - 1. interrupt, warn, or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, obscene, or irrelevant;
 - 2. request any individual to leave the meeting when that person does not observe reasonable decorum;
 - 3. request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
 - 4. call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action;
 - 5. waive these rules with the approval of the Board when necessary for the protection of privacy or the administration of the Board's business.
- G. The portion of the meeting during which the participation of the public is invited shall be limited to thirty (30) minutes, but the timeframe will be extended, if necessary, so that no one's right to address the Board will be denied.
- H. Tape or video recordings are permitted. The person operating the recorder should contact the Superintendent prior to the Board meeting to review possible placement of the equipment, and agrees to abide by the following conditions:
 - 1. No obstructions are created between the Board and the audience.
 - 2. No interviews are conducted in the meeting room while the Board is in session.
 - 3. No commentary, adjustment of equipment, or positioning of operators is made that would distract either the Board or members of the audience while the Board is in session.

DISCUSSION ITEMS

A. Ratification of Collective Bargaining Agreement with the Ludington Education Association

The Ludington Education Association has approved the tentative agreement between the District and the Association. The Board of Education will now need to consider the approval of the Agreement so that the Collective Bargaining Agreement can be ratified between the Board of Education and the Association. Changes to the Collective Bargaining Agreement will be discussed at the meeting on Monday. The major financial provision of the successor agreement includes a step improvement for each employee and a 2% increase in compensation.

B. Ratification of Collective Bargaining Agreement with the Ludington Education Support Personnel Association

The Ludington Education Support Personnel Association has approved the tentative agreement between the District and the Association. The Board of Education will now need to consider the approval of the Agreement so that the Collective Bargaining Agreement can be ratified between the Board of Education and the Association. Changes to the Collective Bargaining Agreement will be discussed at the meeting on Monday. The major financial provision of the successor agreement includes a step improvement for each employee and a 2% increase in compensation.

C. Non-union, Non-affiliated, and Administrative Contracts

The Board of Education approved non-union, non-affiliated, and administrative contracts at a prior Board of Education meeting. These contracts were approved with an understanding that compensation would be frozen until successor agreements were negotiated with the professional and support staff associations that represent employees of the District. This would allow for uniform improvements in compensation to be applied to contracts. It is the recommendation of the Superintendent that a step and 2% increase in compensation be applied to each of these contracts consistent with the step and 2% increase in compensation that is outlined in both the professional and support staff Collective Bargaining Agreements that have been presented to the Board of Education. This does not apply to the Superintendent's compensation, which will remain unchanged and the same as it was during the 2019-2020 school year.

D. Closed Session: Student Disciplinary Reinstatement Hearing

The District has received a request for reinstatement from a student who was expelled from the District after violating Board of Education policy and the Student Code of Conduct in 2019. The student has completed the requirements of the Board of Education for reinstatement, and is requesting to return to school. The Board will need to consider a recommendation for reinstatement.
