Sinking Fund Project Plan (2018 - 2019)

The following list of projects represents the District's initial plans for proceeds from the Sinking Fund for the 2018 - 2019 school year. We will discuss this plan.

Resurface Tennis Courts - \$55,000

Improvements to Foster Elementary School Playground - \$20,000

Replace (1) Set of Pool Lockers and Refinish (1) Set of Pool Lockers - \$32,000

Roof Repairs / Brick Restoration - \$15,000

Repair Baseball Diamond - \$10,000

Ongoing Gym / Parking Lot and Playground Lighting (LED) Replacement - \$30,000

Replace Four (4) Fire Doors at Foster Elementary - \$22,000

Safety and Security Upgrades - \$80,000

Carpet Replacement (OJ, Foster, Franklin, Lakeview) - \$32,000

Remaining / Other - \$50,000

Discussion on Administrative Team Configuration

With the retirement announcement of Jan Jackoviak, an opportunity to discuss reconfiguring the administrative team has presented itself. We will discuss a possible reconfiguration of the administrative team, with the creation of a director's position that could focus on curriculum, instruction, and assessment.

Federal Audit of Title Programs

This past week, the District had a federal audit of its Title programs from the past year. There was a \$17,000 variance in the 3000 and 4000 object codes, within the 221 function code of the District's budget. This was simply due to a misclassification, which was corrected. Of that total, \$72 remains a variance in the budget. Our budget may be negatively adjusted by \$72, unless the State of Michigan classifies this dollar amount as a miscellaneous program classification variance, of which, the \$72 would remain with the District.

Review of Pro Forma Financial Data and Estimated District Millage Study

We will review pro forma financial data for the District, along with estimated millage study documents that have been developed for discussion and planning purposes.
