Middle School Assistant Principal's Position

The posting for the position close on February 16, 2018. First rounds interviews will take place on Wednesday, February 21, 2018, second round interviews will take place on Thursday, February 22, 2018, and a final recommendation to hire the top candidate for the position will appear no later than the March Board of Education meeting. In the meantime, Steve Forsberg will be assisting, along with other members of the complex administrative team, as needed. We have received 36 applicants interested in the position.

Recommendation to Hire High School Special Education Teacher

A committee made up of Dan Mesyar, Steve Forsberg, and three special education teachers completed interviews for the high school special education teaching position that was recently vacated by Erin Slater, as she accepted a position with Traverse City Area Public Schools. The committee has selected its top candidate, and it is our intention to have a final recommendation from the administration to discuss at our Personnel Committee on Friday. The recommendation will be to approve the hiring at our Board meeting on Monday evening. Details of the hire will be provided at the committee meeting, as we are still finalizing reference checks, etc.

MDE Memorandum: Certification Requirements for Library Media Staff

A memorandum from the Michigan Department of Education (MDE) will be provided to the Personnel Committee. We are investigating the impact to Ludington Area Schools at this time, but this serves as a communication with the committee to inform you of this communication from MDE with school districts in the state.

Personnel Specialist Retirement - Mary Jo Heyse
